1. The Pacharauta Municipality **has allocated funds for the Construction Of 15 bed Hospital at the pacharauta Municipality and intends to apply part of funds to cover eligible payments under the Contract for 12/2078/079**
2. Bidding is open to all eligible as per Section V of bidding document.
3. **pacharauta Municipality** invites electronic bids from eligible bidders for the construction of **15 bed Hospital at the pacharauta Municipality** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 14,50,00,000/-**
  - Minimum Work experience of similar size and nature: **minimum two Government Hospital Building Project with HVAC and Medical Oxygen gas plant with Pipeline works of minimum value of NRs 14,00,00,000/-**
4. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously their bid document (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed electronically as per the provision of ITB 21 of the Bidding Document.

Bidders must submit their bid electronically, and should deposit a non refundable fee of Rs.**10,000/-** in the office Rajaswa (revenue) account as specified below .

Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **51,00,000/- or Cash in following Bank Detail**.
